

RESOLUTION No. 12 OF 2016

**A RESOLUTION OF THE TOWN OF McCANDLESS, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, TO
PRESCRIBE RULES FOR PUBLIC COMMENT AT MEETINGS OF TOWN COUNCIL**

WHEREAS, Pennsylvania's Sunshine Act, 65 Pa. C.S. §§ 701 et seq., as well as Sections 405 and 406 of the Town of McCandless Charter, require the Town of McCandless to provide a reasonable period of time at each advertised regular or special meeting of Town Council for residents and taxpayers to address Council on matters of general or special concern, official action or deliberation on matters under consideration by Council; and

WHEREAS, Section 406 of the Charter provides that Council shall adopt and enforce such reasonable rules and procedures as may be necessary for the orderly conduct of its business; and

WHEREAS, the Town Council of the Town of McCandless has determined that both its compliance with the Sunshine Act and the efficient and effective conduct of its meetings and the maintenance of order at said meetings would be advanced by the promulgation of a set of rules regarding such public comment.

NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of McCandless as follows:

Section 1.

1. A separate period of public comment shall be held for each agenda item considered at each advertised regular or special meeting (business meeting) of the Town Council of the Town of McCandless after comments are made by Council, but before the item is voted upon. These comments shall be limited to the agenda items currently before Council. At the end of a regular or special meeting (business meeting), a public comment period will be held for general comments on matters of Town concern. This comment period will be subject to the same rules applicable to public comments.

2. The President of Town Council shall preside over the public comment period and shall recognize residents or taxpayers of the Town wishing to offer comment during such period.

3. Public comment shall be limited to residents or taxpayers of the Town. Any resident or taxpayer wishing to address Town Council during such public comment period shall provide their name and address prior to the public comment period. The Town shall have written forms for such identification prepared and available at each such advertised regular or special meeting of Town Council.

4. Each resident or taxpayer who has signed in and who wishes to speak shall address the President of Town Council and, upon recognition and receiving permission to speak, shall confine his or her remarks to issues or items which constitute matters of concern, official action or deliberation which are or may be before the Town Council and which relate to matters on the agenda except for the open comment period at the end of a regular or special meeting (business meeting).

5. The President of Town Council may rule out of order any offensive, insulting, threatening, scandalous or obscene comments as determined by the President to be disruptive or to otherwise prevent the orderly conduct of the official business of that meeting or who becomes boisterous or who makes threats against any person or against public order and security may be forthwith barred by the President of Town Council from continued attendance at that meeting unless permission to continue shall be granted by a majority vote of those Council members present.

6. Each individual person's comments shall be limited to a maximum of five (5) minutes and each individual shall be given an opportunity to comment on each agenda item at each regular or special meeting (business meeting). When a group of persons wishes to address Council on the same subject matter, it shall be proper for the presiding officer to request that a spokesperson be chosen by the group to address Council and to limit the number of people addressing Council on the same matter so as to avoid any unnecessary repetition. This will not prevent individual members of the group from commenting to the extent that they wish to comment on an issue not addressed by the designated spokesperson.

7. The President of Town Council shall have the authority to call a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action.

8. With respect to Committee meetings, the Committee Chair shall provide for a period of public comment at the conclusion of each Committee meeting, which public comment period shall be governed by the same rules applicable to comments at regular Council meetings. Public comments at Committee meetings shall be limited to comments regarding agenda items for that particular Committee meeting.

9. At each Agenda Review meeting, the President of Council shall provide for a period of public comment after each item on the agenda, which comment period shall be governed by the same rules applicable to public comments at regular Council meetings.

10. The Town endeavors to provide accurate and timely information to questions asked by its citizens. Questions asked during public comment periods will be treated as comments. Answers will be provided by the Town Administration or Town Council as appropriate.


WHEREAS, it is appropriate to recognize the value and the accomplishments of emergency medical services providers by designating the Emergency Medical Services Week; now



I. LegacyLyfe Conditional Use (Warehouse/Distribution category, 9000 Perry Hwy)

The Planning Commission reviewed a conditional use application from Legacy Lyfe Distribution, LLC to operate a Warehouse/Distribution use, packing and crating and warehousing and storage subcategories, in the M-C district at 9000 Perry Hwy. The applicant proposes to use the second floor of the existing office building for a small distribution operation of medical testing equipment which is manufactured in Denver, CO and then delivered to regional clients. The applicant expects a few FedEx trucks per day that would be arriving and departing during normal business hours.

The group discussed specifics of operations and how the rest of the building would be used. Currently there are other medical office tenants and one vacant floor, which LegacyLyfe has interest in expanding to a lab location in the future (currently a use permitted-by-right in this district).

MOTION by Ms. Clarke to recommend Town Council approve the Conditional Use application submitted by Legacy Lyfe Distribution, LLC for a Warehouse/Distribution, Packing and Crating and Warehousing and Storage use in the M-C district with the following conditions:

1. Modify the vehicle loading space shown on the site plan to comply with the sizing requirements of the Town's SALDO, §1104.220(I).
2. Limit the use to the square footage currently shown on the site plan, 1,922 sq ft (or the equivalent of the 2nd floor), with any expansion to require further approval.
3. Limit shipping hours to 7:00 AM–7:00 PM.

SECONDED by Mr. Kline.

Motion passed unanimously (6-0).

A public hearing will be held on this application at Town Council's June 24th regular meeting.

II. Boehler Plan resubmission (9220 Willoughby Rd, new lots to front on Harmony Dr)

The Planning Commission reviewed a subdivision/land development application submitted by Brian Boehler of 9220 Willoughby Rd, proposing to create four new lots from the rear of his property which fronts on Harmony Dr. Stormwater would be managed by individual, privately owned on-lot infiltration systems. This plan had previously been reviewed in 2022 but was withdrawn in order to spend more time working out sanitary sewer connection details. These have since been resolved.

Minor comments remained on the Town Engineer's letter, none of which were material to the design of the plan.

MOTION by Mr. Kline to recommend Town Council approve The Boehler Plan Preliminary/Final Subdivision/Land Development application, contingent on all remaining comments of the Town Engineer's latest review letter being addressed. SECONDED by Mr. DeVito.

Motion passed unanimously (6-0).

The plan is scheduled for consideration at Town Council's May 20th meeting.

III. Tattoo/Piercing Parlor zoning ordinance amendment

The Planning Commission reviewed the Tattoo/Piercing Parlor zoning use amendment currently under consideration by Town Council. Ms. Clarke expressed concern about removing the 250' setback from zoning uses that provide care and services for children, such as schools and daycares, because minors are not legally permitted to have tattoos or piercings performed on them without verified parental permission. Other points of discussion related to the proposal to allow it in all mixed-use (commercial) zoning districts. Some members wondered whether it should only be added as a permitted use in the M-U district, limiting it to M-C and M-U, rather than adding to M-N and TC as well.

The Commission tabled the amendment for further research and discussion at their next meeting. Town Council's public hearing on the amendment is scheduled for June 24th.

I have reviewed materials for the above referenced preliminary/final subdivision plan located between Willoughby Road and Harmony Drive in the R-2 Zoning District. The plan proposes the subdivision of existing Tax Parcel 824-L-58 (3.794 acres) into 5 lots: Lot 1 (0.388 acres), Lot 2 (0.384 acres), Lot 3 (0.384 acres), Lot 4 (0.388 acres), and Parcel A (2.252 acres). In addition, lots are to be graded and utilities extended as required to service the development. The following materials have been reviewed:

- The Boehler Plan and the Plan of Improvement plan set, both prepared by Tait Engineering, Inc. and revision dated April 25, 2024
- Road Cut Plan, Sanitary Sewer Extension Plan and Estimated Earthwork Quantities Plan, all prepared by Tait Engineering, Inc. and revision dated January 30, 2024
- Response to Gateway review letter prepared by Tait Engineering, Inc. and dated January 30, 2024; and an email dated May 2, 2024
- Utility service availability letters
- Planning Module Component 3, approved by ALCOSAN dated January 1, 2024

The following are my comments with respect to the materials submitted in accordance with the Town of McCandless Ordinances.

Subdivision Plan

1. Mathematical closures for the total site and individual lots should be submitted.
(1367.03.c.5) The applicant's engineer has acknowledged this comment and will provide closure reports once the lot layouts have been finalized. This comment will remain until addressed.

Plan of Improvements

1. The proposed subdivision must address the requirements of Section 1104.150 for Recreational Area or a fee in lieu must be paid. *The applicant's engineer stated that a fee will be paid in lieu of. This comment will remain until fully addressed.*
2. The provided Note 8 on the utility plan shall also be added to the plan for recording. State in the note it is the developer's responsibility to install the new electric utility poles between Lots 1&2 and Lots 3&4. Finally, state in the note it is the developer's responsibility to install up to, and including, the cleanout necessary for the rock sump connections.

General Comments

1. The plan must be signed and sealed by the professional preparing it.
2. A DEP Sewage Facilities Planning Module must be submitted for Town consideration, and it will require DEP approval. *The applicant's engineer has stated that the planning module is under review. This comment will remain until final approval from the PA DEP is provided.*
3. The required water and sewer extensions must be coordinated with WVWA and MTSAs, respectively. Any alterations to the proposed design must be submitted to the Town for review and approval.
4. A cost estimate for the items included on the plan of improvements, erosion and sedimentation controls, stormwater, grading, and sidewalks, has been submitted and will be reviewed under separate cover.
5. A development agreement will be required for the project and financial security posted.
6. The Town may have additional comments.

The plan has been reviewed for conformance to Town Ordinance standards only. The review is based on surveys and a plan prepared by others and assumes this information is correct and valid as submitted.
