RE: Monthly Police Activity Report – October 2024

The Town of McCandless Police Department responded to 1,006 calls in the month of October.

The month of October was busy with training for Town of McCandless officers. Our accident reconstructionists attended the Accident Reconstruction Conference presented by the Pennsylvania State Police. We had an officer attend a training relating to PA's commercial vehicle laws. This officer also attended the DUI Symposium learning new case law involving arrests for DUI in Pennsylvania. Our detectives attended both criminal and background investigation classes held by the Allegheny County District Attorney's Office for Detectives. Officers also learned how to diffuse volatile situations with de-escalation and attended training relating to mental health situations.

The entire department completed their yearly low-light firearms qualifications, and the state required defensive tactics training. This included handcuffing, taser deployment and Simunition scenarios. Simunition are plastic projectiles fired from faux handguns that simulate actual gunfire.

A McCandless officer attended Solo Officer Rapid Deployment training. If an officer is called on to enter a building, alone, during an active shooter incident, this training will help him best deploy if faced with this situation.

The officers assigned to the North Hills SRT attended their monthly training.

K9 Officers Davis and Siraly attended their required monthly training. On October 13, they attended Crisis Center North's Paws for Empowerment 4th Annual Pet Walk that occurred in North Park. K9 Officers Davis and Siraly along with K9 teams from Ross, West Deer and Homestead participated and gave a K9 demonstration. On October 20, Officers Davis and Siraly were invited to a local Girl Scout troop event located in McCandless. The troop had a conversation about Siraly and his role with the McCandless Police Department.

On October 12, our officers participated in the North Hills DUI Task Force Roving DUI Patrol. There were forty-four vehicles stopped for various traffic violations and three individuals were administered field sobriety tests. Of those tested, three were arrested for DUI. There were four citations, and forty-one warnings issued for various vehicle code violations.

On October 16, Detective Mike Bock transported 32lbs of unwanted prescriptions relinquished at the McCandless police station to the Ross Township Municipal Building. All unwanted medications were turned over to the PA Army National Guard for disposal.

The department participated in Operation Safe Stop on October 23. Patrol officers followed school buses to observe/enforce any violations when the buses stopped to pick up or drop off students. Zero violations were observed in McCandless.

On Monday, October 28, Detective Sergeant Eric Egli gave two Halloween Safety talks to preschool students at St. John's Church on Cumberland Road.

Re: MFPAA Board Positions

As you know, there has been discussion regarding the Board seats for the McCandless Franklin Park Ambulance Authority. McCandless controls five seats on the Board, and Franklin Park controls two seats. Currently we have two seats that need to be filled, one full term beginning on 1/1/2025, and a second seat to fill a vacancy for a term that expires on 12/31/2025. We have advertised for applicants and currently have received none. We have re-advertised for applicants with a November 30th deadline as well.

It is within our ability to allow applicants from other municipalities that the MFPAA serves to be appointed by McCandless Town Council to fill the board seats that we control. This option allows us a greater candidate pool, and also allows other municipalities to be included in decision making processes on the board. Keep in mind that if we open these seats to applicants from other municipalities, the appointment process and control of seats will remain with McCandless Town Council.

If you should choose to move forward with this idea, a motion and second should be made as follows:

“Motion to allow applicants from all municipalities served by the McCandless Franklin Park Ambulance Authority to be eligible to apply to McCandless Town Council to fill the Town controlled seats on the McCandless Franklin Park Ambulance Authority Board of Directors.”
