

TOWN OF MCCANDLESS
COUNCIL'S ORGANIZATION MEETING MINUTES
JANUARY 5, 2026

CALL TO ORDER

Town Council's Organization Meeting was called to order at 8:00 p.m. by Town Attorney Stephen L. Korbel of Babst Calland, with participation of the following Councilmembers: Doug Arlow (Ward 1), Nick Giorgetti (Ward 3), Joe Wall (Ward 5) and Trish Cloonan (Ward 7). Laureen Alt (Ward 2), Jack Hickerson (Ward 4) and Nathan Babich (Ward 6) were sworn in at the beginning of the meeting and participated immediately afterward. APPOINTMENT OF TEMPORARY CHAIRMAN

Town Councilmembers agreed that Town Attorney Stephen L. Korbel would act as temporary Chairman.

The motion carried (4-0).

Magisterial District Judge Matthew J. Brungo administered the Oath of Office to Councilmembers-elect: Laureen Alt (Ward 2), Jack Hickerson (Ward 4) and Nathan Babich (Ward 6).

ELECTION OF COUNCIL PRESIDENT

A nomination was made by Councilmember Giorgetti to elect Councilmember Cloonan as President of Council. There were no other nominations.

A motion was made by Councilmember Wall and seconded by Councilmember Hickerson to elect Councilmember Cloonan as President of Council.

The motion passed unanimously.

ELECTION OF VICE PRESIDENT

A nomination was made by Councilmember Hickerson to elect Councilmember Giorgetti as Vice President of Council.

A motion was made by Councilmember Wall and seconded by Councilmember Babich to elect Councilmember Giorgetti as Vice-President of Council.

The motion passed unanimously.

The motion carried unanimously (7-0).
