

# Town Manager Toby Cordek retires after 35 years



Over the last 35 years, McCandless has grown up. I have matured along with it. I started here as a 31-year-old Navy veteran having just spent two and a half years as Selinsgrove Borough's manager. McCandless has always had a quiet, subdued nature to it. It was well

known for its pragmatism and conservative approach to governance—and life in general. Shortly after I arrived, McCandless received notice that it was among the safest communities in America. While this was based upon crime statistics, the high quality of life was evident in all of its mix of neighborhoods.

During my first week on the job, PennDOT's local maintenance manager asked me if the Town would be interested in taking ownership of Grubbs, Reichold and Rinaman Roads. I was familiar with PennDOT's "Turn-back" Program, having a similar situation in my previous job. Town Council agreed, knowing that our attention would be greater to these roads. PennDOT planned drainage systems and repaved them — thus beginning a cavalcade of cooperative PennDOT projects over my career here. Arcadia and between McKnight and Route 19 and Sloop Roads also came under Town jurisdiction. Intersection upgrades and reconfiguration, such as Peebles and Duncan, relocation of Arcadia at McKnight, Old Kummer Road at Ingomar in conjunction with Allegheny County, helping with Route 19's Wexford Flats complete corridor makeover including taking a stand with PennDOT that sidewalks would be installed there as Town Council wanted. The grandparent of all of our transportation projects manifested in a Transportation Partnership Act cooperative with PennDOT to extend Duncan Avenue and eventually into what is now McCandless Crossing West; the engineering award winning widening and resignaling of Cumberland Road and Babcock Boulevard, and signalizing Duncan Avenue at Babcock and at McKnight. Just a couple of years ago, we moved at an amazing pace to address the biggest traffic "pain" remaining — the Pine Creek Corridor from the "antique" bridge to McKnight aided by significant funding secured by our State Senator and Representative.


While a good bit of the McKnight Corridor had developed, the section from McCandless Corporate Center (formerly Pittsburgh Research Park) to the McKnight overpass remained underdeveloped. The Planning Commission, Town Council, citizens and I studied and interacted on this area, which resulted in our Performance Zoning (D-Development) District.

It really was a thrill to be part of a team that created innovative zoning which protected the environment, respected existing neighborhoods and continues to maintain Town Council's policy of only public road access, such as Blazier Drive and Duncan Avenue onto McKnight Road.

Challenges and opportunities always presented themselves over these years — from helping to lead the consolidation of 40+ dispatch centers to regional ones to a Central County 911 Center, to implementing automated recycling trash and yard waste collection, creating a revolving fund to sustain fire apparatus procurement, the evolution of stormwater management, to acquisition of 200 acres of active and passive recreation, to enthusiastic participation in various intergovernmental boards and initiatives and equitable and supportive personnel management.

My writing this message is not to say "look what I did." I'm simply glad I could give all I could to help make our Town what it is today. All of these may be deemed accomplishments — but they are all what councils and municipal managers do — improve and sustain the quality of life in their community. It comes from mutual understanding and respect, both at Town Hall, in the neighborhood and at home. It comes from servant leadership and caring, prudent policy-setting by Town Council. I appreciate the opportunity to be part of all of this as your Town Manager for the last 35 years. It truly has been a labor of love. God bless you all.

# Tax deadlines and other important information

## Business Privilege Tax

The tax return and payment are due on May 15 by 5 p.m. The tax office will accept returns as timely if postmarked by the U.S. Postal Service on or before the due date. All returns postmarked after the due date will be considered late and subject to penalty and interest.

## Local Service Tax

Keystone Collections Group collects the local services tax for the Town. This tax applies to any individual who works in the Town at any time during the calendar year, and the rate is \$52 per calendar year.

The tax is withheld by employers and forwarded on a quarterly basis. If you are self-employed or receive compensation for which taxes are not withheld, then you should forward \$13 per quarter.

## Earned Income and Net Profits Tax

Keystone Collections Group collects the earned income and net profits tax for both the Town and the North Allegheny School District for all residents of McCandless. The tax is based on salaries, wages, and net profits earned throughout the year, and is due and payable in quarterly installments.

Under the law, employers are required to have Certificate of Residence forms on file for their employees. When filling out the form, please note that the Town of McCandless PSD code is 710704.

## Per Capita Tax

The Town also collects the per capita tax for the North Allegheny School District. This tax applies to all residents of the Town of McCandless over the age of 21. The rate is \$10 per person, per fiscal year, which runs from July 1 through June 30. The tax for the 2019–2020 school year will be included on your real estate tax bill if you own and occupy a home in the Town. Renters will receive a separate bill in early July.

## Real Estate Tax

The Town collects the real estate tax for both the municipality and the North Allegheny School District for all properties located within the confines of the Town. The tax is calculated by multiplying the tax rate by the assessed value of your home or property.

It is important that you pay your tax by the due dates below, even if you have filed an appeal with Allegheny County. Once a deadline passes, the higher amount must be paid, even if you win your appeal. In addition, failure to pay your tax by December 31 may result in a lien being placed against your property.

## Drop Box Procedures

Please note that tax payments placed in the drop box or hand delivered **before 5 p.m.** are accepted as being timely for the following tax deadlines: May 15 (Business Privilege Tax), September 3 (Real Estate Tax at discount), and November 1 (Real Estate Tax at face).

## 2019 Real Estate Tax Due Dates:

- July 1: Real estate tax bills for 2019 will be mailed
- September 3: Last day to pay 2019 real estate taxes at the 2% discount amount.
- November 1: Last day to pay 2019 real estate taxes at the face amount.
- December 31: Last day to pay 2019 real estate taxes before they become delinquent

If you choose to take advantage of the installment payment program, the due dates for 2019 follow:

- September 3: First installment due
- October 31: Second installment due
- December 31: Third installment due

## Landlord Tenant Listing

Are you aware that if you are a landlord, you are required to disclose the following information? Pursuant to Section 329.06 of the Codified Ordinances of the Town of McCandless and Act 511 of the Commonwealth of Pennsylvania, all owners of rental property within the Town of McCandless shall submit the name and address of all persons occupying such property within 15 days of occupancy. The list shall include all tenants, regardless of whether their names appear on the lease. The Town of McCandless is in the midst of its **tree planting program** to encourage residents and businesses to report the planting of trees on their property.

This will allow for more tree canopy cover in the Town, helping to reduce stormwater runoff (stuff like this also reduces stormwater pollution because trees take up nutrients and pollutants through their root systems).

The Town will tabulate the number of trees planted within a 5-year period (starting in March 2018) to determine how much sediment has been removed from its stormwater (with a little help from the state DEP guidelines).

# And now a few important notes on recycling from Waste Management

## Keep Calm and Recycle

### Recycling Update from Waste Management

By now you have probably heard a lot about changes in the recycling industry and the need to be mindful about what we are putting into the recycling bin.

We should probably first talk about how we got here before we discuss what we can do.

Most of us are guilty of being "wishcyclers". We hope and wish everything we put into our recycling bin can be recycled. And once an item is in the bin, we assume it will be recycled.

That's not the case, though, for close to 25% of material in our recycling bins across western Pennsylvania. That 25% represents contamination, or residue, and is material that ultimately ends up at the landfill.

**For years the recycling industry has been telling people to put something in the recycling bin and let the sorting facility take care of it. But we need a new strategy.**

Last year, Waste Management exported about 30% of recyclables to markets in China. However, in July of 2017, China notified the World Trade Organization of its intent to ban the import of certain recyclables by 2018. Along with a ban of 24 materials, China also finalized its contamination standards in January of this year, limiting contamination for any material imported into the country to less than 0.5%. These regulations require all markets to continue focusing on quality, which starts with the material we accept at our facilities.

We are now 10-months into these new regulations and have seen their effects across the globe. Impacted by basic supply and demand economic principles, recycling commodity markets plummeted

#### Here are a few tips you can follow to be a good recycler:

1. Keep plastic bags out of curbside recycling. Material must be placed loose into your recycling cart. Looking to recycle your plastic bags? Take them back to your local retailers.
2. Keep material clean and dry.
3. Look at the shape of plastic containers instead of the number – recycle only plastic bottles, plastic jars and plastic jugs.

due to the global over-supply of recyclables and simultaneous reduced demand, driven by China's restrictive import policies. These policies are creating challenges for recyclers and communities.

**The focus to clean up contamination is incredibly important to the quality of recycling programs. If we want to find stable markets for our material to, we must eliminate contamination.**

Waste Management recycles because it's the right thing to do, and our customers want us to do the right thing. Once your materials come to our facility, we want to be able to sort and separate all the recyclables and find producers who can use these materials to make new ones. It makes us all proud in the industry when we can help the environment and meet our customer's expectations.

However, we need to simplify what we are putting in our recycling bin; get back to the basics of good recycling and recover quality material from our streams.

We need customers to focus on recycling clean and dry bottles, jugs, jars, cans, paper, and cardboard. These items have strong end markets when they're recycled, and you can make an impactful difference.

It's easy to be a wishcycler, hoping every plastic or paper item we use is recyclable. But that isn't the case anymore. For something to be recycled we must have an end market for the material, and right now, we need time for new end markets to develop.

**If we focus on recycling items we know are recyclable, it is much more likely our efforts will make an impact.**



## Contamination 101

### What it looks like and why it's important to address it

As recycling programs have grown and transitioned to single stream processes, recycling simply has become more confusing to consumers and WM has seen a significant uptake in contamination. Contamination in the waste stream increases the risk to WM workers, raises the cost of recycling, and hampers our ability to recycle effectively (and in some cases results in products not being recycled). By targeting the following items and preventing them from ending up in the recycling, we can clear up the waste stream, keep workers safe, and make a difference for recycling.

#### Plastic Bags

##### What's the problem?

- They interfere with the machinery – WM workers have to enter clogged machinery in order to remove plastic bags. Bags jam up the screens that separate recyclables from other material meaning fewer recyclables are captured. The machines have to be cleared manually which is risky for WM staff.
- They can make other recyclables look like trash – Bagging your recyclables in plastic adds another step to the sorting process. Specialized labor is necessary to unbag these materials, making recycling a more expensive process. Additionally, if they are confused for trash, these materials cannot be recycled.

##### What to do:

- Place recyclables loose in your bin. Find out where you and your community can recycle plastic bags at [plasticfilmrecycling.org](http://plasticfilmrecycling.org).



#### Non-Program Materials & Bulky Items (e.g. hoses, car parts, etc.)

##### What's the problem?

- Cumbersome items have to be removed from the waste stream manually – This can be risky for sorters and increases the labor costs of recycling, which raises the overall cost of recycling.
- The equipment can't handle big heavy items – They cause jams, break machinery, and can lead to plant shut downs, all of which limit WM's ability to recycle efficiently.

##### What to do:

- Check local programs for local reuse and recycling options first, before putting them in your waste bin. Visit [Earth911.com](http://Earth911.com) to find programs available in your area.



#### Liquid and Food

##### What's the problem?

- It contaminates the recyclables – Food-soiled recyclables are less valuable to buyers, which increases the cost of recycling. Liquid and food that is released in trucks or in recycling facilities attracts pests that lead to unsafe working conditions.

##### What to do:

- If available, put eligible items in the compost, otherwise use the trash container.

# FREQUENTLY ASKED PUBLIC SAFETY QUESTIONS

## TOWN OF McCANDLESS POLICE DEPARTMENT

### Does the Town require a permit when someone is selling door to door?

The Town requires any transient vendor to obtain a permit. You may ask to see the permit that has been issued by the Town. Transient vendors may operate with their permit from Monday through Saturday, between the hours of 9 a.m. and sunset. Persons who go onto residential property within the Town to solicit funds must also be registered with the Town. They are required to have an identification card issued by the Town. Their hours of operation are as follows:

- 9 am – 5 pm, Monday – Saturday, October 1 – April 30
- 9 am – 9 pm, Monday – Saturday, May 1 – September 30

Groups or individuals that solicit funds on business properties within the Town are also required to have a Town issued identification card.

### Does McCandless have a dog ordinance?

The Commonwealth of Pennsylvania requires the owner of any dog to keep at all times such dog either confined within the premises of the owner, firmly secured by means of a collar and chain or other device so that it cannot stray beyond the premises on which it is secured, or under the

reasonable voice control of some person. Dogs are also required to be licensed, quarantined if they bite, and vaccinated. Dog license applications are available at the police station.

### Is loud noise illegal?

Municipal ordinance prohibits loud, unusual, and unnecessary noise that annoys, injures, or endangers the comfort, repose, health, or welfare of nearby residents or visitors. The ordinance is not applicable to the use of lawnmowers, chainsaws, and other mechanical or motorized tools commonly used on residential property, provided the same shall only be used during daylight hours, but not before 8 a.m., prevailing time, and shall not be used in the operation of any business on the property. The ordinance is not applicable to noise created by normal land development between 6 a.m. and 10 p.m.

### Can a person or corporation distribute advertising information at my residence?

The Town has an ordinance that prohibits any person, firm, or corporation from distributing advertising materials at a residence by placing such material at a residence, on the property, or on the mailbox of the person owning or occupying the residence unless the person, firm, or corporation, its agents, servants, employees, and/or independ-

ent contractor distributing such materials is doing so at the resident's request or through the use of the United States Postal Service.

### What emergency preparedness plans does the Town have?

The Town of McCandless has developed an Emergency Management Plan to assist and protect residents should a catastrophe occur. All emergency service providers are an integral part of the Town's Emergency Management Plan. The plan includes provisions for warning notifications to be transmitted to residents via available media outlets and by public safety vehicles equipped with public address systems.

The plan also offers provisions of food, water, and shelter to emergency or disaster related events.

The Chief of Police is the emergency management coordinator for the Town (his deputy is the Town Fire Marshal). Any resident who has a question pertaining to emergency management situations or who has an interest in assisting, identifying, and providing resources that may be used during emergency situations, can call them at 412-369-7992.

# Check out the **At Your Door** **HHW and E-Waste Collection**

As a part of the Town's contract with Waste Management, residents have a convenient new opportunity to dispose of **Household Hazardous Waste** — such as cleaners, chemicals and automotive products — and **E-Waste** — such as old computers, televisions and other electronics.

The At Your Door HHW and E-Waste Collection program allows residents to easily dispose of these often difficult-to-recycle items.

## How to participate...

**First**, you have to schedule your collection. There are three ways to do this:

The call center operators will guide you through the steps toward a safe and successful collection. You will be asked several questions, including your address and the type and amount of materials available for the pick up. You will be provided a convenient collection date and information about where to place the kit for collection. A kit will be sent to your home in plenty of time for you to gather and pack your materials.

## Preparing for collection

The collection kit includes an instruction sheet and other items to help pack and secure your household generated special materials. Please read the instruction sheet included in the kit.

## Preparing for collection

On the scheduled date, the customer service technician will collect materials directly from your home. They will sort and pack the materials for proper transportation, recycling and disposal. Participants will receive a postage-paid survey card to complete and mail back to help track the program.



# Consider the snow ...



**The Town of McCandless snow and ice control program** provides for the salting and plowing of snow from streets within the Town. This vital maintenance service is performed on 110 miles of Town roads and 20.12 miles of state owned roads. This state road mileage encompasses all state roads in the Town with the exception of Route 19 and McKnight Road, but includes their ramps. Public Works Department crews also offer plowing to approximately 18 miles of private roads in times of heavy snowfall (6"+ accumulation) upon request.

All **sidewalks** must be cleared in a reasonable amount of time as circumstances permit, preferably within 24-hours after a snowfall. Please use caution when moving snow and help those who may have health problems or are not able-bodied. In addition, please do not shovel or blow snow from the sidewalk to the street.

## The policy for snow and ice control within the Town is as follows:

- Bare pavement maintenance will be provided whenever possible on all contracted state roads, Town roads, and roads in new developments that will become Town roads (after these same roads are paved and houses are occupied by residents), divided into 9 routes that are prioritized by volume and steepness.
- Fire department entrances and ambulance authority entrances shall be salted and/or plowed when work is accomplished in each snow and ice control route.
- Private roads (non-Town roads having two or more residences) shall be plowed after the above services are performed, whenever six inches (6") or more of snow is accumulated. Due to the nature of these private roads, plowing will be done only at the request of residents along these roads.
- A form entitled "Request & Release for Plowing of Private Road" is available for property owners on private roads requesting plowing assistance from the Town. **ALL** property owners on a private road must sign the release. Plowing will only be done after an accumulation of six or more inches of snow and after all public roads have been cleared.

Severe road conditions prompt some drivers to leave their vehicles on Town Streets. Vehicles parked on streets during such conditions make some operations extremely difficult and jeopardize the safety of motorists and vehicles. Vehicles must be parked off-street as soon as possible so the Town can conduct its snow operations effectively.
