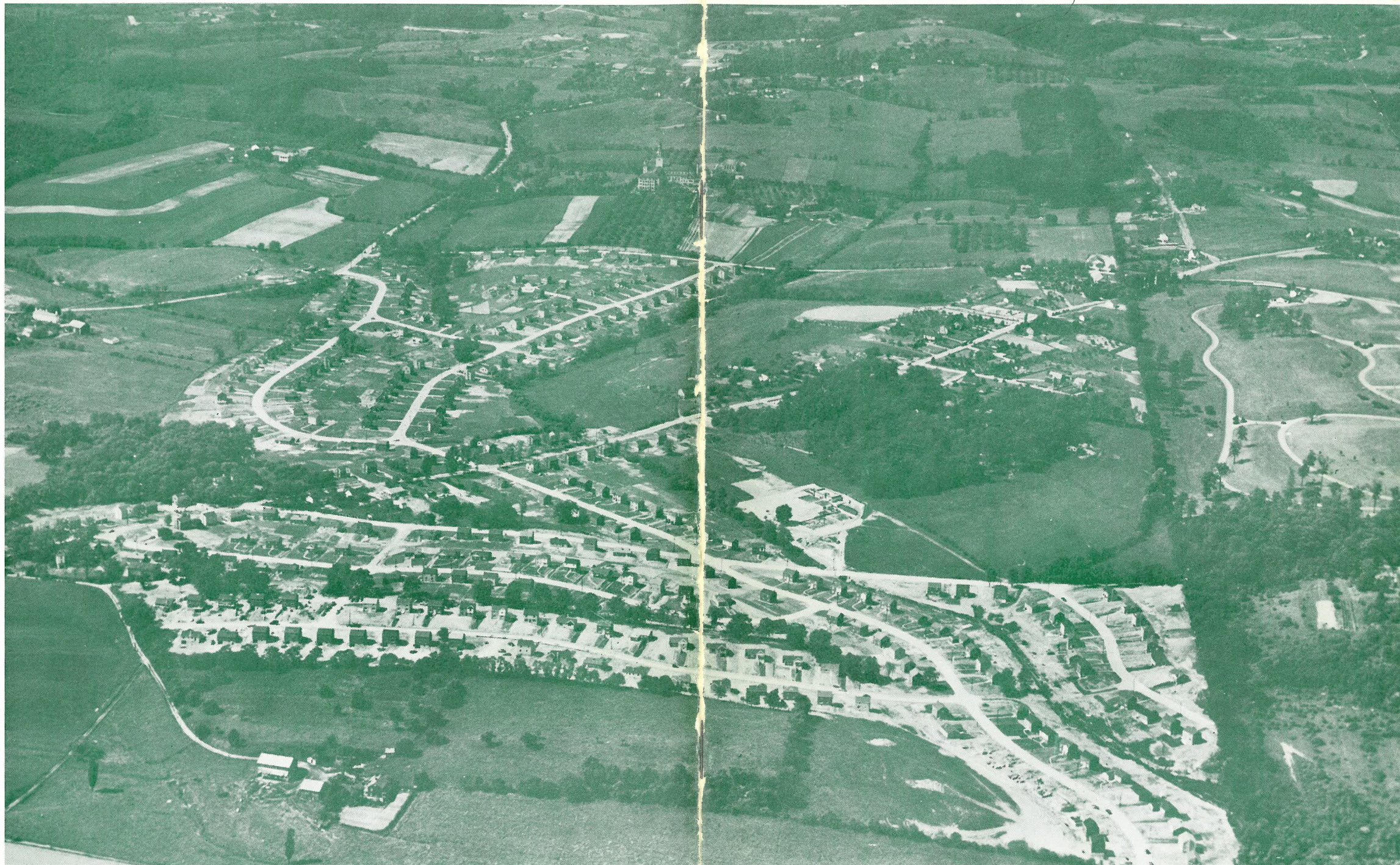

ANNUAL REPORT

1958

This is the fourth Annual Report to the citizens of McCandless Township of the workings of the Township Government since the adoption of the Council-Manager Form of Government. In these pages the individual citizens of McCandless Township will find a record of the many types of work done by Township Personnel, as well as an account of the moneys given to the Township in trust by the Tax Payer.

Abraham Lincoln said that it was his hope that "Government of the People, by the People, for the People shall not perish from the earth." Such a government as he wished to perpetuate is one which depends entirely upon the individual citizen.

In this report it has been shown that each one of the 13,637 citizens of McCandless Township has a share. That share is shown for each item of income to the Treasury and also for each item of expenditure by the Township for its many services to its citizens.

Your Board of Commissioners and the Manager appreciate the cooperation of each Township resident in all things which have been done during 1958. Every effort has been made to do things which at present or in the long run will be for the best good of not only the individual in the Township but for the Township as a whole.

Should any resident have any questions or should any of the Township citizens have any criticisms, your Board of Commissioners and the Manager will be happy to hear them and consider action necessary to answer them.

The Board of Commissioners of McCandless Township is an elected body composed of 7 members each of whom represents one of the 7 Wards of the Township. The Commissioners are elected for overlapping terms of 4 years. The Commissioners for the even numbered Wards will be elected in 1961 at the General Election and those for the odd numbered Wards will be elected in November of 1959.

The Board has the responsibility for all legislative matters for the Township. By its function, Ordinances and Resolutions are enacted and put into record; the annual budget is approved; salary schedules and fees are fixed; and Taxes are levied.

The Board has appointed a Township Manager to assist it with the Administrative work and this Officer is responsible for implementing and carrying out the policies of the Board. The Board also appoints a Solicitor who serves as a representative of the Township in Court Action and advises the Board on matters of Law. The Planning and Zoning Commission and the Sanitary Authority are appointed by the Board.

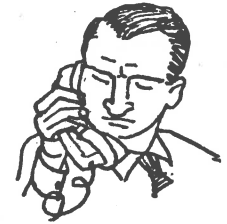
During 1958 the Board met in a special meeting for the purpose of Organization; held 12 Regular Meetings, and conducted 19 Public Hearings. The meetings of the first six months of the year were held in Espe School, after which the Township transferred its meeting place to Peebles School. Meetings are held on the fourth Monday of each month at 8:00 p.m. Public hearings precede the Regular Meetings by opening at 7:30 p.m.

The Board of Commissioners enacted 33 Ordinances, passed 22 Resolutions. The Ordinances deal with the following subjects:

Since 1954, McCandless Township has operated under the Council-Manager form of Government with the present Manager. In 1958, the Office of Township Secretary was combined with that of Manager and S. V. Erdelyi assumed both positions as Manager-Secretary.

As Manager, he supervises all of the Departments of the Township, except Police, in their general activities and directs the personnel under him to carry out the details of their functions. The Manager prepares the annual Budget for the approval of the Board of Commissioners, and under this Budget, controls the financial activities of the several Departments. He keeps the Commissioners constantly abreast of the fiscal condition of the Township.

As Secretary, Mr. Erdelyi is responsible for the signing of all Official Township documents and for the recording of the minutes of the Township Meetings. The detail work of correspondence and stenographic work is delegated by the Secretary to his Secretary who is a full time employee of the Administration Department.

Based on knowledge and with the aid of experience in the position, assisted by the suggestions and criticisms of residents of the Township, and with the understanding of the desires of the Board of Commissioners, the Manager-Secretary assumes the responsibility for implementing the policies of the Board and assures that these are carried out successfully.

Legal expenses included in Administration amount to \$15,125.55, which amounts to \$1.14/capita. This amount includes \$6,498.75 paid to Mr. Geer, \$4,170.65 to Mr. Smith, and the remainder for Boundary Case and Court Costs.

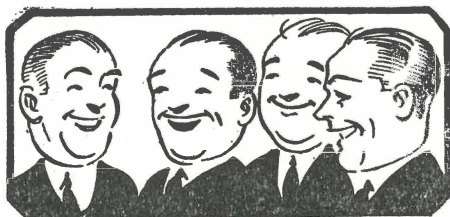
TOWNSHIP BUILDINGS

The Township operates its various functions from three locations. The Administration Offices, Police Department and Wage Tax Office are in the Old Peebles School Building, 1390 Duncan Avenue. The Department of Public Works has its headquarters and garage in the Old Municipal Building at 9512 Old Perry Highway and has its storage yard on Ingomar Road just west of Grubbs Road. It has long been the aim of the Board of Commissioners to consolidate all these activities in one area.

In 1954 the sum of \$32,000.00 was taken from the Wage Tax Account and budgeted toward the cost of a new Municipal Building. Since that time, this amount has been held in a Capital Reserve Fund and is set aside for the purchase of a new site.

During 1958, the Board of Commissioners were fortunate in being able to purchase for \$30,000.00 a site containing approximately 10 acres just west of Richards Grove between Pump Station Road and Grubbs Road. This piece of property has been zoned Commercial for another purpose but was never used. With the purchase of the property came the added incentive to carry out the plans for the new Headquarters, the Manager along with Board Members have visited several Municipal Buildings in the neighborhood and have begun a study for plans for the future construction.

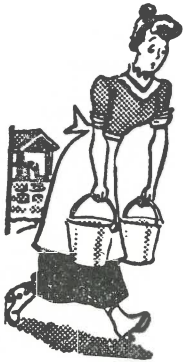

Two other items remain in the budget, Miscellaneous and Administration. The former, amounting to \$9,197.15 is paid from the balance of the Tax money plus the share of the Wage Tax expense from the School District. The Administration amount, \$44,243.84 is paid from other sources. Cash remaining is \$10,317.78 or \$0.75 per capita.

WATER DISTRICTS



During 1958 a number of water lines were increased in length or installed. The water line along Ingomar Road was extended to the Franklin Township line for the purpose of supplying the new school. The lines were put in for the following developments: Brown & Vaughn Fox Ridge Plan, Blumenschien Meadow Brook Manor, Park Meadows No. 4, Crestwood Manor, and the Haller Plan including Meadow Road.

Water Districts were created or completed during the year. The Venango Drive and Venango Place District 1-B which included a Fire Plug on East Arcadia Drive authorized by Ordinance No. 154 was completed. The Highland Plan Water District 4-G was authorized by Ordinance No. 180 but not completed.

The West View Water Authority has supplied the following costs which will be of interest to many residents of the Township.

If water is put in by establishment of a Water District or by a Developer, the "tap-in" charge for each resident is \$55.00 for a three-quarter inch tap or \$75.00 for a 1 inch tap.

If the Water Line is put in by the West View Water Authority, the cost for each resident's "tap-in" is \$355.00 for a three-quarter inch tap or \$375.00 for each 1 inch tap.

It has also been pointed out that residents along a new water line will be charged for the installation costs on the basis of the cost for each front foot.

ZONING BOARD OF ADJUSTMENT

The Zoning Board of Adjustment, appointed by the Board of Commissioners, held twelve regular monthly meetings and four special meetings during 1958 hearing 41 appeals. Twenty-nine variances were granted, 1 petition was refused, and in 11 other cases, the Board gave advice as to proper action.

The Board of Adjustment is composed of the following members: Louis E. Wirth, Jr., is the Chairman, John Ehrhard and Frank Foley comprised the membership at the end of the year. Mr. Foley was appointed to serve the unexpired term of Mr. J. W. Rodgers who left the Board to accept an appointment to the Sanitary Authority. L. H. Harris, Building Inspector, serves as Secretary to the Board.

The purpose of the Board is to hear appeals of those whose application for building permit issuance has been refused due to zoning violations or restrictions. The Board takes into consideration any unnecessary hardship which strict adherence to the Ordinance might inflict.

On March 14th, the Board drew up and approved a new set of By-Laws for its action. These were submitted to the Zoning Committee on April 14th and referred from that Committee to the Board of Commissioners who by Motion approved them on April 28th.

The Board of Adjustment holds its regular meeting on the Fourth Friday of each month in the Township Offices, 1390 Duncan Avenue.

In 1958, the Township added 3.25 miles of streets to the highway system which now totals 48.20 miles of Township streets.

The present Township equipment consists of 3 large trucks, a 1-Ton Truck, a 3/4-Ton Pick-up Truck, a Willy's Jeep, Hough Payloader (Hi-lift and backhoe combination), Grader, Roller, Huch Asphalt Tar Kettle, Spreader Box and an Air Compressor.

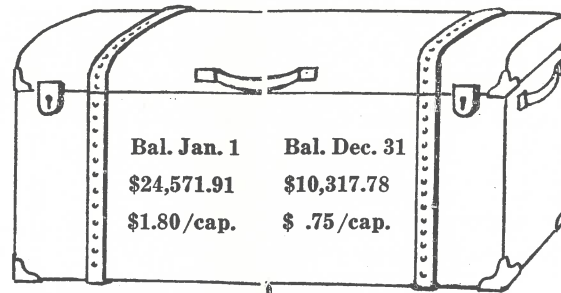

During 1958 the Planning Commission held 28 regular and special meetings at the Township Office. The regular meetings are held on the 1st and 3rd Tuesday of each month at 8:00 p.m. In addition, The Planning Commission visited numerous locations in connection with the planned sub-divisions. As a result of these meetings, 42 plans on sub-divisions or zoning changes were reviewed. Of these cases, 36 were recommended to the Board of Commissioners for approval.

During 1958 the Planning Commission submitted to the Commissioners a report on the Comprehensive Plan, which is the result of several years of work of the Planning Commission together with professional planners. The revised zoning ordinance was reviewed by the Planning Commission and recommendations were submitted to the Commissioners for clarification. In view of the revised zoning ordinance, the proposed Master Plan and the proposed Zoning Ordinance will have to be revised to conform with the recently revised lot requirements.

SANITARY AUTHORITY

During the past year the Sanitary Authority continued its efforts towards the solution of the sewage disposal problem in McCandless Township. By March of 1958 an understanding was reached with the Ross Township Authority, Ross Commissioners and the Commissioners of McCandless Township for joint use and ownership of Lowries Run Trunk Sewer, constructed by Ross Township. The use of this sewer would allow the collection of all sewage in the Lowries Run Drainage area in McCandless Township and its delivery to the Allegheny County Sanitary Authority Sewage Treatment Plant. Unfortunately, the boundary dispute between McCandless and Ross Townships necessitated a complete revision of this agreement. A new agreement designed to meet any possible relocation of the boundary was completed and should be ready for execution early in 1959.



The Sanitary Authority has, in addition, been studying the other drainage areas of McCandless Township with the aim of determining the feasibility of providing them with sewerage and sewage treatment facilities. The Sanitary Authority had studied and reported to the Board of Commissioners on the possible effects of the extension of existing franchised, privately owned, P.U.C. controlled, sewerage collection and sewage treatment facilities within the Township.

During the past year, two changes in the composition of the Board occurred, one due to departure from the Township and the second due to resignation. The Sanitary Authority wishes to thank Messrs. Walters and Platt who served the Township so faithfully during their terms in office. These gentlemen were replaced by Messrs. Joseph Rodgers and John Hyle who were appointed late in the year. Other members who served on the Authority during 1958 were M. A. Shapiro, Chairman; Walter Guldbrandsen, Vice-Chairman; Phillip Brunn, Jr., Treasurer. Mr. William Murdock continued to serve as consulting Sanitary Engineer and Mr. William Markus as Attorney.



INSPECTION DEPARTMENT

In addition to making the Building and Plumbing Inspections, this department has worked closely with the Allegheny County Health Department in making inspections of Septic System installations. Before a Building Permit may be issued, the approval of the County Health Department must be secured for the property involved. Before an Occupancy Permit may be issued, the approval of the system installed must be given by the County Health Department. In each of these phases of construction, the Inspection Department has a share.

Permits of all sorts which affect the building trade must be applied for in this department, and are issued by it if all requirements are met. Should there be some reason for variances or exceptions necessary, the applicant is referred to the Zoning Board of Adjustment whose approval must be given before the permits may be issued.

During 1958, the Department issued 209 Building Permits, 134 Plumbing Permits, 87 Permits for Septic System installation, 54 Driveway Permits, bringing into the Treasury of the Township a sum of \$7,610.12. The property value of the structures built or altered amounted to \$5,227,623.00.

The inspector made 620 regular inspections as required on the buildings, plumbing, and septic system installations. In addition, periodic checks were made as work progressed in each phase of construction.

The Inspection Department was responsible for the Township Zoning Map in order that it be kept up to date in line with Zoning Changes and Subdivision developments.

The supervision of the collection of garbage is another function of the Inspection Department, and the system instituted in 1956 was continued. The 7 Garbage Collectors have continued since that date, and in 1958 they each signed new contracts which will be in force for a period of two years. The fact that there were only 9 complaints received by the Department in 1958 speaks well for the co-operation of the Collectors in satisfying the needs of the people of the community.

The Allegheny County Health Department Northwest District, in addition to the regulating of the Septic System installations provides for the Township other services, such as Public Health Nursing, Health Education, Restaurant Inspections, and the collecting and reporting on Water Samples. Their new Offices are located in McCandless Township on McKnight Road at Perrymont Road in the Medical Building. Their telephone number is FOrest 4-0400. Dr. Howard P. Cadwell, M.D., is the Director for this area.

CIVIL SERVICE COMMISSION

The Civil Service Commission met on January 6, 1958 to organize with the following results: Earl M. Fretwell, Chairman, Frank X. Weis, Secretary. The third member of the Commission is Walter Locher.

In the early months of the year, the Commission studied with the aid of books procured for it by the Board of Commissioners, the duties of such a Commission, and then in June began preparation for the examinations for the positions to be established in the Police Department.

On November 29th, the examination for Captain-Lieutenant was held with Patrolmen Geisler, Blakley and Yingling as the candidates.

On December 27th, the examination for Sergeant was held with Patrolmen Geisler, Blakley, Yingling, Toth and McCabe taking it.

As the year ended, the Commission was taking the necessary steps preparatory to holding examinations for Patrolman. Seven applications had been received, but medical examinations had not been completed, thus the final examinations could not be given.

POLICE DEPARTMENT

The McCandless Police Department consists of the Chief, 7 patrolmen, 4 desk clerks, 8 School Guards, and 14 Auxiliary Police. The entire Township is covered at all times by motor patrol cars which are in constant contact with the Headquarters through 2-way Radio manned on a 24-hour per day basis.

The Police Cars, 1 Sedan and 1 Station Wagon-Ambulance combination car, are rented on an annual basis. The fully equipped ambulance is available to all residents of the Township for emergencies. The following table gives a report on the activities and cost of operating these cars in 1958.

It may be noted that in 1958, the income to the Township from Motor Vehicle Violation fines was \$7,440.00, which amounts to \$106.77 more income than the amount spent on the two Police Cars used in the Township.

Each year one of the Police Officers attends the Police Training School at Hershey, Pa., for a period of 3 months. Yearly, all Police Officers with less than 4 years service, receive "In-Service Training" for 3 hours weekly for 26 weeks at a Police School held by the Department of Public Instruction for the State and sponsored by the North Hills Police Association.

FIRE PROTECTION

Fire protection for McCandless Township is provided by three excellent Volunteer Fire Companies, each of which is fully equipped.

Highland Fireman's Association, Ray Wittmer, President and W. L. Walker as Chief, answered 41 calls in 1958.

Ingomar No. 2 Volunteer Fire Company, Miles Stump, President and James Cook as Chief, were called out 32 times in 1958.

Peebles Volunteer Fire Company, William Kукets, President and J. C. Hunsinger, Chief, filled 38 calls in 1958.

The Central Fire Alarm Base Station is located in the Township Building from which point sirens for all Companies are activated. Each Fire Company has a smaller Base Station so that the network between bases, trucks and portable equipment will be complete and 2-way communication for all fire equipment is possible.

Ohio Township Police and Fire Departments are also on the McCandless Radio Network, and during 1958, 18 fire calls were received at the Base station and transmitted to the Fire Company.

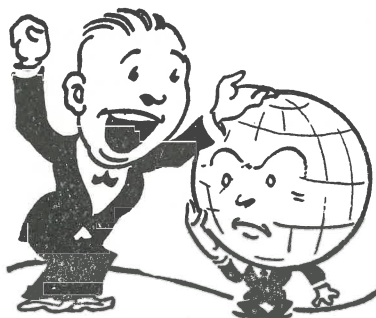
McCandless Township, through Federal Government Civil Defense Matching Funds, purchased the 2-way radios for all of the Township fire equipment.

During 1958, \$4,904.37 was spent for fire hydrants in the Township. Each of the three fire companies received \$3,000.00 for general expenses from the Township Budget. \$62.80 was spent for Civilian Defense supplies.

CIVIL DEFENSE

Chairman, James E. Hergenroeder of the McCandless Township Civil Defense Organization, continued its program for the year 1958. While public apathy constantly deters activity in such a Defense Group as this, interest was held up within the Organization locally. The 14 Volunteers who worked during a 9 week training period, each were sworn in as Auxiliary Police. These men have served in many varied capacities to assist the Police Department and the Firemen. They are constantly alert to any call by Police Chief, Harry Wylie, in case of any emergency. Additional members of the Civil Defense Organization are needed and volunteers will gladly be accepted.
