**APPROVALS**

1. MTSA ( McCandless Township Sanitary Authority )  
Application, sketch and check in amount of \$50.00 must be submitted to MTSA 418 Arcadia Drive, Pittsburgh, PA 15237 for approval.

**The application will be returned to the applicant following MTSA preliminary approval.**

2. Municipal Authority of the Borough of West View ( WVW )  
Application, sketch, and any WVW fees must be submitted to WVW at 99 Reis Run Road, Pittsburgh, PA 15237. WVW will review and provide their approval.
3. ACHD ( Allegheny County Health Department ) Plumbing Division  
Prior to starting installation the applicant or plumber must file plans with ACHD 3901 Penn Avenue, Bldg. 5 Pittsburgh, PA 15224. ACHD fees will be required.

**Your receipt of MTSA, WVW and ACHD approval is your notice to proceed with installation of the deduct meter.**

**INSPECTIONS**

4. Upon completion of the deduct meter installation, the following agencies must be called for an on-site inspection:
  1. MTSA, Call (412) 366-3420 to schedule. Call 24 hours in advance to schedule. If the meter is installed correctly the MTSA inspector will seal the meter and sign the application
  2. ACHD, Call (412) 578-8036 to schedule. Call before 9:00 A.M. for same day inspection. If approved the ACHD inspector will sign the application
  3. WVW, Call (412) 931-3292 to schedule. If approved the WVW inspector will sign the application.

**AFTER APPROVAL OF ALL 3 AGENCIES RETURN THE APPLICATION TO MTSA. NO CREDIT WILL BE GIVEN UNTIL THE COMPLETED APPLICATION IS RETURNED.**
