ORDINANCE No. 1474

**AN ORDINANCE OF THE TOWN OF MCCANDLESS, ALLEGHENY
COUNTY, PENNSYLVANIA, AUTHORIZING THE TOWN OF
MCCANDLESS TO ENTER INTO AN AGREEMENT WITH THE NORTH
ALLEGHENY SCHOOL DISTRICT TO PROVIDE SCHOOL RESOURCE
OFFICERS TO THE DISTRICT**

WHEREAS, the Home Rule Charter of the Town of McCandless requires, in Article V, Section 504, that Town Council authorize by ordinance the undertaking of any substantial contract or other commitment of the Town with respect to the sharing or coordination of municipal functions or services with other governmental entities or agencies; and

WHEREAS, pursuant to Part One (“Administrative”) of the Codified Ordinances of the Town of McCandless, Section 117.05(d), such an ordinance is classified as a “Class C” ordinance which requires advertisement and posting of the ordinance before adoption by Council; and

WHEREAS, the Town Council of the Town of McCandless has determined it to be in the best interests of the health, safety, and welfare of the residents and citizens of the Town for the McCandless Police Department to provide a uniformed police presence in the form of School Resource Officers in certain school buildings within the Town to deter criminal behavior and to protect students, teachers and administrators; and

WHEREAS, the North Allegheny School District has agreed to reimburse the Town of McCandless for costs incurred in connection with establishment of the School Resource Officer program as more fully set forth herein.

NOW THEREFORE, it is hereby ORDAINED by the Town Council of the Town of McCandless, Allegheny County, Commonwealth of Pennsylvania, as follows:

SECTION 1:

The above recitals are incorporated herein by reference.

SECTION 2:

The Town Council of the Town of McCandless hereby authorizes an Agreement between the Town and the North Allegheny School District to establish a School Resource Officer program under which McCandless Police Officers will be assigned to work in school buildings owned and operated by the School District under terms more fully set forth herein.

SECTION 3:

The Town Council hereby authorizes the Council President and Town Manager to execute an Agreement in substantially the form attached hereto as **Exhibit A**, which Agreement is incorporated herein by reference, in order establish the terms under which the School Resource Officer program will operate, include the terms under which the North Allegheny School District will reimburse the Town for costs incurred in connection with the program. Any material change to the terms of the Agreement must be approved by a majority vote of Town Council.

SECTION 4:

If any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall remain in full force and effect; and to this end, the provisions of this Ordinance are hereby declared to be severable.


SECTION 5:


All resolutions, ordinances, or parts thereof, of the Town of McCandless which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of any such inconsistency.
